<p>Comment on the school's community, locality and relevant history.</p> <p>Lansdowne and Eton Park Junior are both situated in an area of high social deprivation. These are areas of high crime rates. The local park (Eton Park) is a regular venue for anti-social behaviour including underage drinking, drugs and knife crime.</p> <p>We serve a multicultural community with approximately 56% of our pupils coming from ethnic minorities. A total of 13 languages are spoken within the schools. There is no racial tension within school but we are aware this is not the same within the local community.</p> <p>We work closely with local councillors and the Police.</p>

We are aware that the local secondary school where many of our pupils transfer and have siblings (The de Ferrers Academy) have contextual safeguarding risks of Child Sexual Exploitation (CSE) and knife crime.

Support for pupils

Both academies have a detailed and comprehensive PSHE curriculum. We follow the Jigsaw curriculum in the main but have personalised this to meet the needs of our learners. Jigsaw covers all aspects of the National Curriculum programme of study. We supplement this with materials from the NSPCC, Barnardos, Young Minds. We also welcome parents/carers and visitors into the school, such as the Police, to share in educating the citizens of the future.

We ensure that sites are secure, with 6ft fencing and a door entry system installed to ensure unannounced or unwelcome visitors are not permitted. Children are well prepared for lockdown procedures; this is practised every half term. We liaise with parents over the timings of this so that they can support the school in discussing this at home.

Both academies have a large safeguarding and pastoral team. This is led by the Executive Principal. Developing emotional health has equal importance to raising standards. We are currently working towards achieving the Carnegie Award for Mental Health. As well as whole school education, we offer bespoke support packages for individuals, in order to address their needs. This could be Hope, Nurture, Positive play, Lego therapy or 1:1 drop in sessions (counselling). We have several staff trained in both academies to deliver programmes. On occasions, if there is a need, staff will travel between the academies in order to offer the most suitable provision. We have an open door policy whereby parents/carers are also able to access support.
